On 4 July 08 at 1809 hours officers were dispatched to the Area of 400 E. 35th Pl. In reference to a DUI/hit-n-run.

David Fulps heard a collision from his residence, at 1411 E. 36th St. Fulps ran out and chased a white Buw Two Block till he crashed in a yard, Fulps walked up to the drivers door. The driver got out, G-IORDANO, of the car and said he had to leave and he could not be caught because he worked for channel 8. G-IORDANO TOLD FULPS he could have what he wanted if he let him go. G-IORDANO walked away, approx 4 blocks to 35th & Trenton, where the police arrived.

OFC. T. ESPY and J. Johnson made first contact with G-IORDANO. He was unsteady on his feet, had blood shot eyes, slurred speech and had an odor on/about his person/Breath commonly associated w/ the consumption of alcoholic beverages. OFC. ESPY instructed G-IORDANO on the HON and she showed six out of six clues. OFC. ESPY stopped G-IORDANO from doing the One leg stand and Nine step walk and Turn due to his level of intoxication. OFC. ESPY placed G-IORDANO in handcuffs. OFC. S. Johnson read OIC TO G-IORDANO, while OFC. Johnson was reading OIC, off a card, he kept saying "Not going to happen." When OFC. Johnson Asked G-IORDANO to take the state test he stated "No." G-IORDANO stated to officers "I have been drinking beer this Afternoon." and "I know I am drunk." G-IORDANO Asked several times, "what would it take to make this go away." When G-IORDANO was placed in handcuffs he lost control of his bowels and had feces running down his legs. Subject kept reaptly asking the same Question and could not remember the answers.

I arrested G-IORDANO, I transported him Tulsa county Jail for Book Pn. SEE TRAVIS ACCIDENT FORM 2008-043332. TUSA was called to the scene.
