ON 1/20/17 AT APPROXIMATELY 0138 I WAS RIDING AS 3C116 WHEN I WAS DISPATCHED TO A CALL TO BIN 73 ON NW. 73RD AND WESTERN IN REFERENCE TO A DISTURBANCE.

WHEN I ARRIVED OFFICERS WERE MAKING CONTACT WITH THE MALE WHO LATER IDENTIFIED AS AR. I WENT INSIDE THE BUSINESS AND MADE CONTACT WITH IP AND VI.

VI IS ONE OF THE BARTENDERS AT THE BUSINESS. VI STATED THAT HE KNOWS AR AS A REGULAR IN THE BAR. VI STATED THAT AR GOT INTO AN ALTERCATION WITH SOMEONE WHO HAD ALREADY LEFT. WHEN AR AND THE UNKNOWN PARTY WERE ARGUING AR STARTED TO TAKE OFF HIS JACKET. VI TOLD AR TO LEAVE HIS JACKET ON AND CALM DOWN. AR TURNED HIS AGGRESSION ON VI AND PICKED UP A BOTTLE OFF OF THE BAR AND ADVANCED TOWARD VI. VI REPEATEDLY TOLD AR TO PUT THE BOTTLE DOWN. AR GRABBED VI BY HIS THROAT AND PUSHED HIM AGAINST THE BAR. AR HELD VI AGAINST THE BAR BY HIS THROAT UNTIL OTHER MEMBERS OF THE STAFF GRABBED AR AND PULLED HIM OFF OF VI.

VI WAS ADAMANT ON PRESSING CHARGES AND SIGNED A CITATION AGAINST AR. VI STATED THAT THEY WILL HAVE VIDEO FOOTAGE OF THE INCIDENT THAT WILL BE AVAILABLE ON A LATER DATE.

I SPOKE WITH IP WHO STATED THAT HE WAS OUTSIDE THE BAR SMOKING WHEN AR AND THE UNKNOWN PARTY WERE FIGHTING IN THE PARKING LOT. IP TRIED TO BREAK UP THE FIGHT AND AR PUNCHED IP IN THE FACE. AR THEN GRABBED IP'S THUMB AND TOLD IP THAT HE WOULD BREAK IT. IP WAS INTOXICATED AND DID NOT SIGN A CITY CITATION. IP DID NOT HAVE ANY VISIBLE INJURIES.

I MADE CONTACT WITH AR AND PLACED HIM UNDER ARREST FOR ASSAULT AND BATTERY. I PLACED AR IN HANDCUFFS, DOUBLE LOCKED THEM, AND CHECKED THEM FOR TIGHTNESS. I PLACED AR IN THE BACK SEAT OF MY SCOUT CAR. I HAD NOT SPOKEN WITH AR PRIOR TO HIS ARREST AND I READ AR HIS MIRANDA RIGHTS FROM MY CARD AT 0210 HOURS. WHEN I ASKED AR IF HE WISHED TO TALK TO ME HE STATED NO.

I TRANSPORTED AR TO THE OKLAHOMA COUNTY JAIL AND BOOKED HIM IN UNDER THE ABOVE LISTED CHARGE WITHOUT INCIDENT.
