Vonna,

Superintendent Walters' attendance at this event would need to meet the definition of official state public purpose business. State law and numerous Attorney General Opinions require that any expense with state (public) funds must be for an official public purpose. I can see where there could be a public purpose if a person was making a presentation on a state issue, but to attend such an event just to be there, could be questionable for meeting the official public purpose requirement.

If you can show support for the travel meeting this criteria then I suppose the agency could purchase airfare and lodging using the P-card.

Below is the law where travel payments must be based on state business.

§74-500.2. Reimbursable expenses of state officials, employees and certain others.

- A. Officials and employees of the state, traveling on authorized state business, may be reimbursed for expenses incurred in such travel in accordance with the provisions of the State Travel Reimbursement Act and existing statutes relating to state travel.
